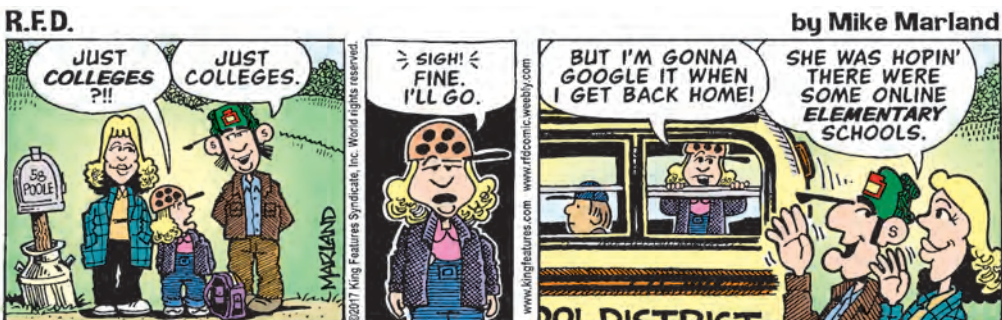

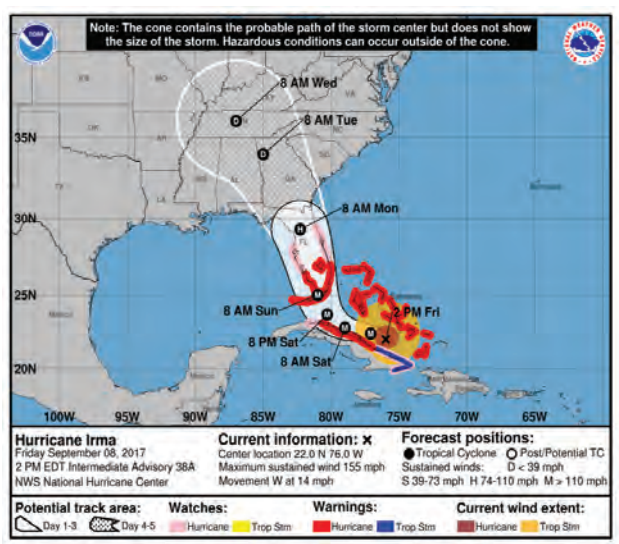

## Empty shelves, lines for gas

There were shortages of water and other supplies at many local retailers this week as residents tried to prepare for Hurricane Irma, which roared into our collective consciousness as a Category 5 storm earlier

this week and has stayed there since.

The need to have gas also led to long lines at gas pumps and shortages of fuel in some locations.

Those shortages were caused in part by the exodus of Florida residents fleeing the storm.

On Friday, CNN said the evacuation could be the largest in U.S. history.

From cancellations to evacuations, storm brings normal life to a halt

If local residents aren't prepared for what comes with Hurricane Irma, it won't be for a lack of trying.

It seems like preparations for the storm have been going on for a month, as various public safety agencies and offices in Liberty and Long counties have tried to ensure the safety and well-being of residents.

Here are the updates and notices the Courier received through Friday:

First, Georgia Gov. Nathan Deal on Thursday declared a state of emergency for 30 counties ahead of any potential impacts of Major Hurricane Irma.

The 30 counties under a state of emergency are: Appling, Atkinson, Bacon, Brantley, Bryan, Bulloch, Burke, Camden, Candler, Charlton, Chatham, Clinch, Coffee, Echols, Effingham, Emanuel, Evans, Glynn, Jenkins, Jeff Davis, Liberty, Long, McIntosh, Pierce, Screven, Tattnall, Toombs, Treutlen, Wayne and Ware Counties.

In the release, Deal announced a mandatory evacuation which began Saturday for Chatham County, all areas east of I-95 and some areas west of I-95.

The Liberty County Board of Commissioners issued a county-wide mandatory evacuation for all areas of Liberty County effective Saturday morning. Hinesville followed suit with a mandatory evacuation on Thursday.

All residents are asked to moni-

Liberty County Administrator Joey Brown said there will be no shelters open or available in the county.

During a hurricane meeting held Thursday, that included all county essential personnel, Brown explained that the county does not open shelters, the American Red Cross does.

He noted the Red Cross does not open shelters in coastal communities that may be prone to flooding or storm surge.

Liberty County Sheriff Steve Sikes said emergency responders and personnel, including police officers, EMS, firefighters, utility crews and more will be unable to perform any rescue or emergency functions once the

area begins to experience tropical storm force winds.

Liberty EMA Assistant Director Larry Logan said Liberty County could begin to experience tropical storm force winds as early as Sunday morning.

### LONG COUNTY

Long County issued a voluntary evacuation that started at 3 p.m. Thursday. The county was considering a mandatory evacuation order late Friday.

The county will retain essential personnel and they are expected to report to work as normal. According to the Long County Sheriff's Office, First Baptist Church is opening their doors to senior citizens, and

THE STATE OF GEORGIA  
EXECUTIVE ORDER

BY THE GOVERNOR:

- WHEREAS:** On September 6, 2017, due to the potential impact of Hurricane Irma as forecasted by the National Hurricane Center, I declared a State of Emergency for Georgia's six (6) coastal counties; and
- WHEREAS:** Due to the updated National Hurricane Center forecast, through its five (5) day cone model, Hurricane Irma will potentially produce excessive rainfall and damaging winds, causing extensive flooding, fallen trees and the closure of numerous roads in additional Georgia counties; and
- WHEREAS:** The network of coastal and rural roads may be rendered impassable in many areas of the impacted counties, isolating residences and farms from access to essential public services; and
- WHEREAS:** The assistance of the government of the state of Georgia is necessary to protect the public health, preserve the safety of the public, keep property damage to a minimum and restore the social and economic welfare of impacted counties; and
- WHEREAS:** The authority is vested in the Governor by virtue of O.C.G.A. § 38-3-51 to issue reasonable orders, rules and regulations deemed necessary to protect public health, safety and welfare, and bring the emergency situation under control within the acknowledged limitations of the powers of the Governor.
- NOW THEREFORE, PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY**
- ORDERED:** That a State of Emergency exists in the following counties: Appling, Atkinson, Bacon, Brantley, Bryan, Bulloch, Burke, Camden, Candler, Charlton, Chatham, Clinch, Coffee, Echols, Effingham, Emanuel, Evans, Glynn, Jenkins, Jeff Davis, Liberty, Long, McIntosh, Pierce, Screven, Tattnall, Toombs, Treutlen, Wayne and Ware.

IT IS FURTHER

- ORDERED:** That all citizens East of Interstate 95 along Georgia's coastline mandatorily evacuate this region beginning at 8:00 a.m. on Saturday, September 9, 2017. The mandatory evacuation will be a phased evacuation at the direction of the Georgia Emergency Management and Homeland Security Agency in cooperation with county emergency management agencies.

IT IS FURTHER

- ORDERED:** That the Georgia Emergency Management and Homeland Security Agency oversee the contraflow of a portion of Interstate 16 beginning at 8:00 a.m. on Saturday, September 9, 2017, to better facilitate the movement of citizens out of the impacted area.

IT IS FURTHER

- ORDERED:** That the Georgia Department of Defense provide up to 5,000 Georgia National Guardsmen to be used in preparation, response and recovery efforts associated with Hurricane Irma within the state of Georgia.

IT IS FURTHER

- ORDERED:** That these National Guardsmen be called up to State Active Duty, as necessary, by the Adjutant General.

IT IS FURTHER

- ORDERED:** That all resources of the state of Georgia be made available to assist in preparation, response and recovery activities in the above mentioned counties, and the Georgia Emergency Management and Homeland Security Agency activate the Georgia Emergency Operations Plan.

This Executive Order shall be valid for a period of fourteen (14) days, beginning on September 7, 2017, and ending at 11:59 p.m. on September 21, 2017.

But Sunday's paper wasn't the half of it. Once we finished this one, and that while also trying to keep our website and social media pages updated, we turned around and got the inside pages of next week's Coastal Courier and our sister paper next door, the Bryan County News, together so that those pages, too, were ready to print regardless of what happens in the next day or two.

And we'll all deal with that if that's the case. But remember, if the worst happens, or anything close to it, that it's not just you in a fix.

It's everyone, including those in government, and law enforcement, and public safety, and health care, and those who work to get the power back on.

It's easy to blame when things go wrong. It's easy to make decisions when you aren't responsible for them.

Yet anything human is less than perfect to begin with, and that includes government, business, our school systems, everything. It's people who have got families to evacuate, or not.

They've got to eat, and sleep, and deal with all the same issues the rest of us will have to deal with after this storm passes, whatever those issues may be.

Understand too that dealing with a large population can be akin to herding cats, to use an old cliché.

It's certainly that way dealing with reporters, who are generally an independent minded bunch who don't like being told what to do and when to do it.

That's what makes reporters reporters, and I bring it up because it's also what makes us Americans.

Most of us want to know why we're being told something, and even then there's no guarantee that we'll agree with it, or understand it, or follow instructions like evacuation orders, mandatory or otherwise.

We're also gifted with folks who like to sharpshoot and can always do things better than the folks who do them, and that's fine. Sometimes they're even right.

But hindsight is 20-20. Dealing with a potential Category 5 storm and herding cats is always easier after the fact, whatever that fact is.

The thing is, no matter how much one plans for these sort of events, there's really nothing you can do about them except do the best you can with what you have. That, and try to be nice to one another, and help where we can.

So that's what we'll do. Be safe out there. See you next week.

THIS DAY IN...  
HISTORY



On Sept. 13, 1814, Francis Scott Key pens a poem that is later set to music and in 1931 becomes America’s national anthem, “The Star-Spangled Banner.” The poem, originally titled “The Defence of Fort McHenry,” was written after Key witnessed the Maryland fort being bombarded by the British during the War of 1812.

On Sept. 15, 1858, the new Overland Mail Company sends out its first two stages, inaugurating government mail service to the western U.S. In 1857, Congress had authorized a \$600,000 yearly subsidy for whatever company could transport the mail twice a week from St. Louis to San Francisco in less than 25 days.

On Sept. 17, 1923, a fire threatening the University of California at Berkeley kills two people and destroys nearly 1,000 houses, including half of the fraternity and sorority houses. The National Guard was quickly called in to stop the looting.

Disabled can sign up for future evacuation assistance

With the approach of Hurricane Irma, public health officials strongly encourage residents in Liberty County who may have functional, access, or medical needs and no way to evacuate — should that become necessary — register with their county health department.

It’s too late for Irma’s approach, which is expected to be at its worst for our area Monday into Tuesday. But the officials point out that hurricane season will run through November.

To apply, residents should call the Liberty County Health Department at 912-876-2173 as soon as possible.

The Functional, Access, and Medical Needs Registry is made up of residents who may require transport and medical assistance during a hurricane evacuation and have no other resources such as family, friends, neighbors, or church members to help them if they need to evacuate. Residents must apply to be on the registry.

Those on the registry will be evacuated to an American Red Cross shelter in an inland county that will likely be in a gymnasium or similar setting and could be several hours away. The registry is a last resort, but if a hurricane is threatening our area, it is important that health department officials know where the most vulnerable residents are located so that evacuation assistance can be provided to them. People living in nursing homes, assisted living facilities, and personal care homes are not eligible for the registry and must follow their facility’s emergency plan.

Functional and Access Needs registrants are individuals who may need services to maintain their independence in a shelter. This includes children and adults with physical, sensory, mental health, and cognitive and/or intellectual disabilities affecting their ability to function independently without assistance. Medical needs registrants are individuals who require support of trained medical professionals. This includes those individuals who may need assistance with managing unstable, terminal, or contagious conditions that require observation and ongoing treatment.

Deer archery season is open

Hunters using archery equipment got their first opportunity to bring home a deer beginning Saturday, according to the Georgia Department of Natural Resources' Wildlife Resources Division.

Last year, 139,043 archery hunters harvested just over 50,000 deer. Statewide, hunters can use archery equipment throughout the entire 2017-18 deer season.


"Archery season is an excellent time to get an early start on putting some venison in the freezer," said state deer biologist Charlie Killmaster. "Although it's still warm this time of year, it's the easiest part of the season to pattern deer. Just don't forget to report your kill to Georgia Game Check!"

Georgia hunters can

check out an interactive map that allows them to see the best opportunities available for the counties they hunt at georgiawildlife.com/rut-map.

All hunters must report their deer harvest through Georgia Game Check, including hunters under 16 yearsold, landowners, honorary, lifetime, and sportsman license holders. Hunters will need to obtain a free deer harvest record each season.


Before moving a harvested deer, hunters are required to immediately enter the date and county on the harvest record, and within 72 hours, must complete the reporting process through Georgia Game Check (gooutdoorsgeorgia.com) OR hunters can go "paperless" and report through the free Go Outdoors GA app (you can report through the app even with no connection.



## SINS THAT CRY OUT TO HEAVEN

There are sins that cry out to heaven for justice. The slaughter of Abel by his brother Cain is the primordial example. A premeditated murder of one's brother certainly cries out for justice. The oppression of the Israelites in Egypt is another sin that cried to heaven, and throughout the Bible we see the oppression of the poor, of orphans and widows, and of refugees as sins that God is particularly inclined to avenge. The Book of Exodus makes this principle explicit: "Do not mistreat or oppress a foreigner, for you were foreigners in Egypt. Do not take advantage of the widow or the fatherless. If you do and they cry out to me, I will certainly hear their cry. My anger will be aroused, and I will kill you with the sword; your wives will become widows and your children fatherless." (Exodus 22:21-24 NIV) This is a moral exhortation that is all too relevant today, when millions of refugees have no place to call home and widows and orphans are all around us. Ask yourself who in your community fits the bill of the widow, the orphan or the foreigner. We might call them by different names, i.e., single mothers, or undocumented immigrants, or the homeless and working poor, but these people are God's children, and they have a special place in His heart.

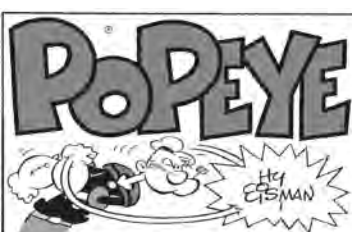

# Things to consider after a hurricane

## Advice and information from the American Red Cross

### What to do after a hurricane

- Continue listening to a NOAA Weather Radio or the local news for the latest updates.
- Stay alert for extended rainfall and subsequent flooding even after the hurricane or tropical storm has ended.
- If you evacuated, return home only when officials say it is safe.
- Drive only if necessary and avoid flooded roads and washed out bridges.
- Keep away from loose or dangling power lines and report them immediately to the power company.
- Stay out of any building that has water around it.
- Inspect your home for damage. Take pictures of damage, both of the building and its contents, for insurance purposes.
- Use flashlights in the dark. Do not use candles.
- Avoid drinking or preparing food with tap water until you are sure it's not contaminated.
- Check refrigerated food for spoilage. If in doubt, throw it out.
- Wear protective clothing and be cautious when cleaning to avoid injury.
- Watch animals closely and keep them under your direct control.
- Use the telephone only for emergency calls.

### Returning home

Preparing to return home after evacuating will keep you safer while inspecting and cleaning up the damage to your home. Before traveling, ensure local officials have declared that it's safe to enter your community and that you have the supplies you will need. Follow the suggestions below for returning to, inspecting and cleaning your home.

Items to take when returning home:

- ✓ Government-issued photo ID and proof of address
- ✓ Important phone numbers
- ✓ Bottled water and non-perishable foods
- ✓ First aid kit
- ✓ Cleanser/hand cleaning gel for personal use
- ✓ Hygiene products and toilet paper
- ✓ Insect repellent and sunscreen
- ✓ Long sleeved shirts, long pants, sturdy waterproof boots and work gloves
- ✓ Flashlight, portable radio and extra batteries
- ✓ Cameras for photos of damage for insurance claims

### Before returning

- ✓ Find out if it is safe to enter your community or neighborhood. Follow the advice of your local authorities.
- ✓ Carry plenty of cash. ATMs may not work and stores may not be able to accept credit or debit cards.
- ✓ Bring supplies such as flashlights, batteries, bottled water and non-perishable foods in case utilities are out.
- ✓ Create back-up communication plans with family and friends in case you are unable to call from affected areas.
- ✓ Plan for delays when traveling. Bring extra food, water, pillows, blankets and other items that will make the trip more comfortable. Keep the fuel tank of your vehicle as full as possible in case gas stations are crowded, out of fuel or closed.
- ✓ Carry a map to help you route around heavy traffic or impassable roads.
- ✓ Find out if local medical facilities are open and if emergency services are functioning again. Do not call 9-1-1 or the local emergency number to do this.
- ✓ Understand that recovery takes time. Focus on the positive and have patience. Others

will have similar frustrations

### First inspection

- ✓ If possible, leave children and pets with a relative or friend. If not, keep them away from hazards and floodwater.
- ✓ Beware of rodents, snakes, insects and other animals that may be on your property or in your home.
- ✓ Before entering your home, look outside for damaged power lines, gas lines, foundation cracks and other exterior damage. It may be too dangerous to enter the home.
- ✓ Smell for gas. If you smell natural gas or propane, or hear a hissing noise, leave immediately and contact the fire department.
- ✓ If your home was flooded, assume it is contaminated with mold. Mold increases health risks for those with asthma, allergies or other breathing conditions.
- ✓ Open doors and windows. Let the house air out before staying inside for any length of time if the house was closed for more than 48 hours.
- ✓ Turn the main electrical power and water systems off until you or a professional can ensure that they are safe. Never turn the power on or off, or use an electrical tool or appliance while standing in water.
- ✓ Check the ceiling and floor for signs of sagging. Water may be trapped in the ceiling or floors may be unsafe to walk on.

### Using generators safely

- ✓ When using a portable generator, connect the equipment you want to power directly to the outlets on the generator. Do not connect a portable generator to a home's electrical system.
- ✓ If you are considering getting a generator, get advice from a professional, such as an electrician. Make sure that the generator you purchase is rated for the power that you think you will need.

### Let your family know you're safe

If your community has experienced a flood, or any disaster, and you can't reach family and friends by phone, you can register on the American Red Cross Safe and Well website, available through [RedCross.org](http://RedCross.org), to let them know about your welfare. You can also call 1-866-GET-INFO to register yourself and your family. Conversely you can check the site for information about others you want to know about.

### Cleaning your home

- ✓ Wear protective clothing, including rubber gloves and rubber boots.
- ✓ Be careful when moving furnishings or debris since they may be water logged and heavier.
- ✓ Throw out all food, beverages and medicine exposed to flood waters and mud, including canned goods and containers with food or liquid that have been sealed shut. When in doubt, throw it out.
- ✓ Some cleaning solutions can cause toxic fumes and other hazards if mixed together. If you smell a strong odor or your eyes water from the fumes or mixed chemicals, open a window and get out of your home.
- ✓ Throw out items that absorb water and cannot be cleaned or disinfected (e.g. mattresses, carpeting, cosmetics, stuffed animals and baby toys).
- ✓ Remove all drywall and insulation that has been in contact with flood waters.
- ✓ Clean hard surfaces (e.g. flooring, countertops and appliances) thoroughly with hot water and soap or a detergent.
- ✓ Return to as many personal and family routines as possible.

### Caution: Carbon monoxide kills

- ✓ Never use a generator, grill, camp stove or other gasoline, propane, natural gas or charcoal-burning devices inside a home, garage, basement, crawlspace, or any partially enclosed area. Locate unit away from

doors, windows and vents that could allow carbon monoxide to come indoors.

- ✓ The primary hazards to avoid when using alternate sources for electricity, heating or cooking are carbon monoxide (CO) poisoning, electric shock and fire.

### As you rebuild

- Secure double entry doors at the top and the bottom.

- Select trees that are not as subject to uprooting to replace damaged ones. A gardening or landscaping professional can give you excellent advice.
- Identify a place to store lawn furniture, toys, gardening tools and trash cans that is away from stairs and exits to prevent them from being moved by high winds and becoming missiles. Ask a professional to
- Ensure roof sheathing is properly installed.
- Ensure end gables are securely fastened to the rest of the roof.
- Fasten the roof to the walls with hurricane straps.
- Elevate your home if it is near the coast and subject to flooding from storm surge.

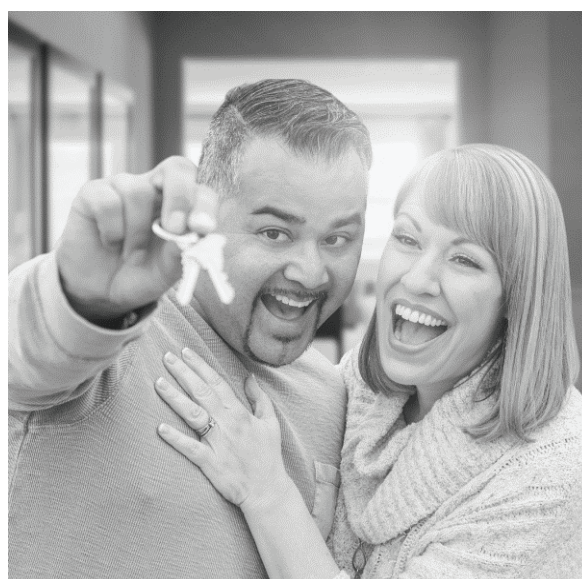

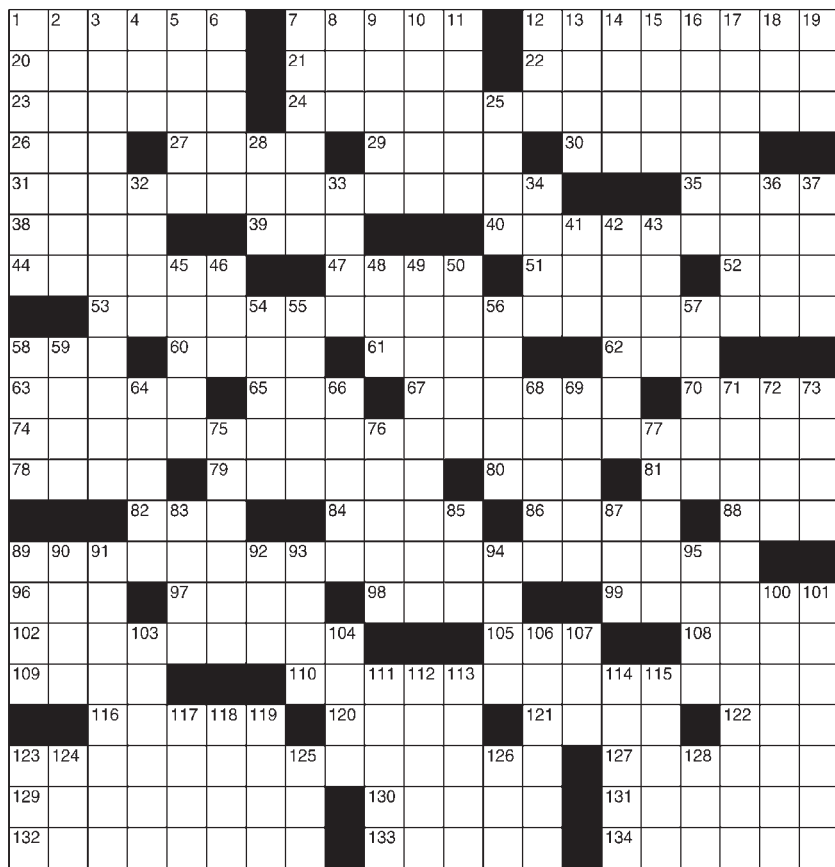

# Yu Spa looking to pamper clients

Lisa Guo opened Yu Spa in 2013 in order to carry on the specialized modalities used by massage therapists and body work professionals she grew up around her whole life. She said it was massage therapy and the healthy and holistic lifestyle that encompasses most in that line of work that helped her lose more than 100 pounds several years ago.

“I used to be real heavy...and I used massage to help me lose weight and reduce stress,” she said adding that she now uses massage therapy to take care of others. “I love being able to help people get rid of their pain.”

Guo became a licensed massage therapist in 2009 and said she was drawn to Hinesville because of its close proximity to the military base.

“I always wanted to join the army but I am too old to join now,” she said. In return Guo loves serving the military community helping them de-stress.

Yu Spa offers an array of therapeutic services. Guo said the two most popular treatments are the Deep Tissue massage and Swedish massage.

Swedish massage focuses on relaxation, Guo said. Deep Tissue is the most popular and Guo said when done correctly it helps to loosen tight muscles and flush out toxins from the body tissues. She said folks booking a Deep Tissue Massage are encouraged to drink plenty of water beforehand, which helps reduce soreness afterwards.

Yu Spa also specializes in prenatal massage. She said her staff has received specialized training in the delicate modality and it is a safe way to get some relief on specific pressure areas associated with pregnancy.

Guo offers Reflexology at her spa. This specific treatment is more than a mere foot massage. Reflexology is a specialized modality that uses the pressure point system taught in Traditional Chinese Medicine. The most popular method of Reflexology is applied to the feet but can be done on the hands and ears as well. Reflexology involves pressure being applied to specific reflex points which correspond to different body organs and systems. It is said to have beneficial effects on a person’s health.

“Sometimes when I am massaging a person’s feet I can tell if they have stomach issues or health issues,” Guo said. By focusing on the pressure points, clients are able to alleviate ailments.

Guo offers free hot stone treatments to all military personnel and also with any massage that is 60 minutes or longer.

Guo said she finds her work rewarding “Sometimes people come into my office hurting...not being able to even walk upright and when they finish their massage they feel better,” she said. “That’s why I do it.”

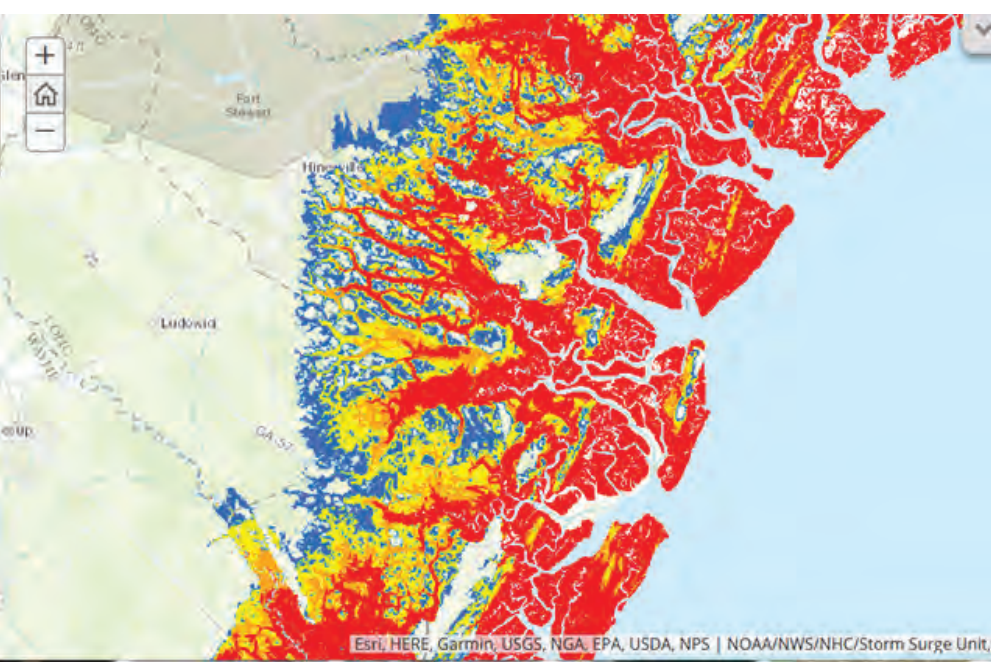
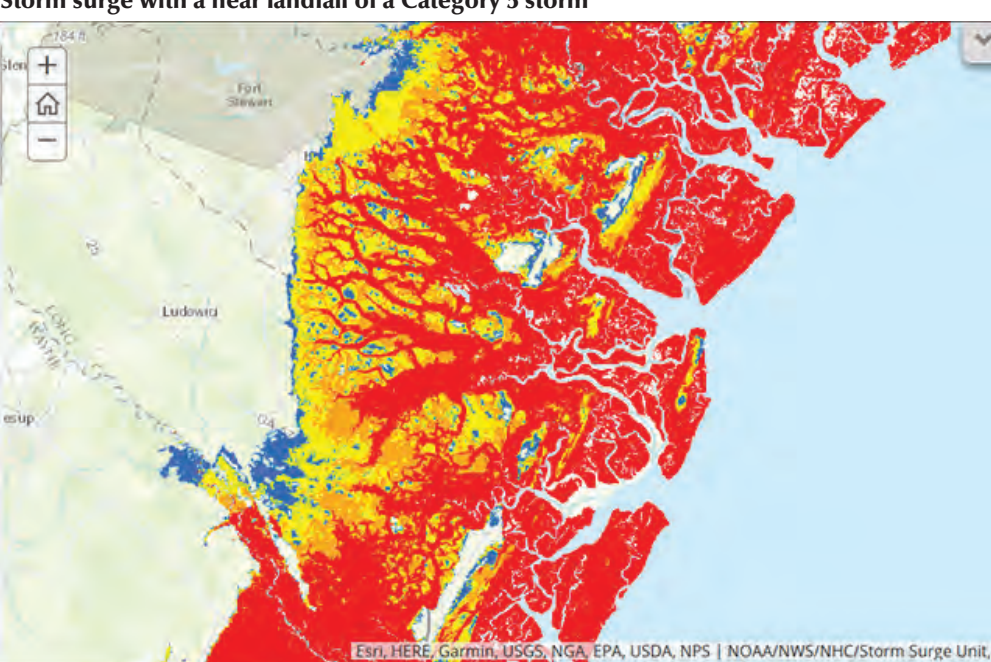
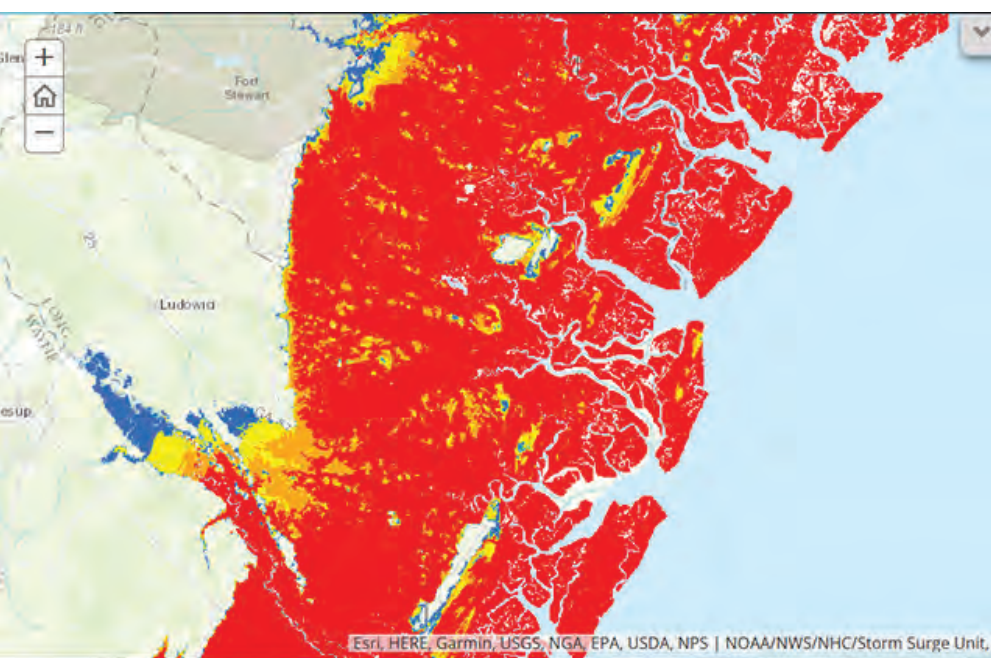

## What storm surge could do to area

Reports of more than 50 inches of rain falling on the Houston area last month from Hurricane Harvey, and reports of 170-180 mph winds in threatening Hurricane Irma overshadow another deadly aspect of tropical storms — storm surge.

The National Hurricane Center's Storm Surge Unit studies the impact of surge and issues maps showing what

could be flooded by winds pushing sea water ashore. The accompanying maps show the Georgia coast from just south of Savannah to about Eulonia.

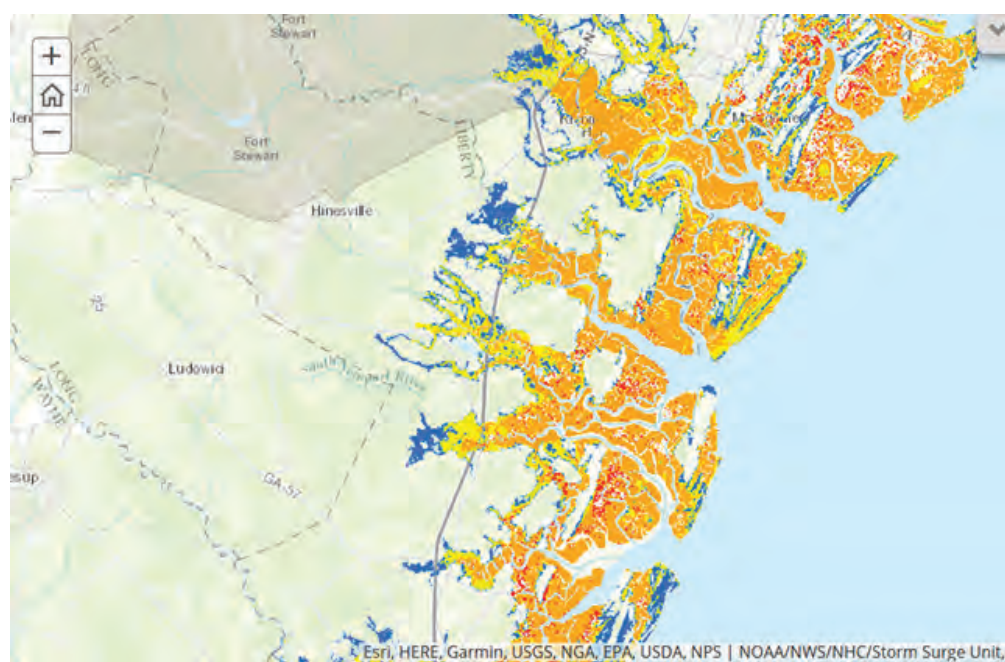
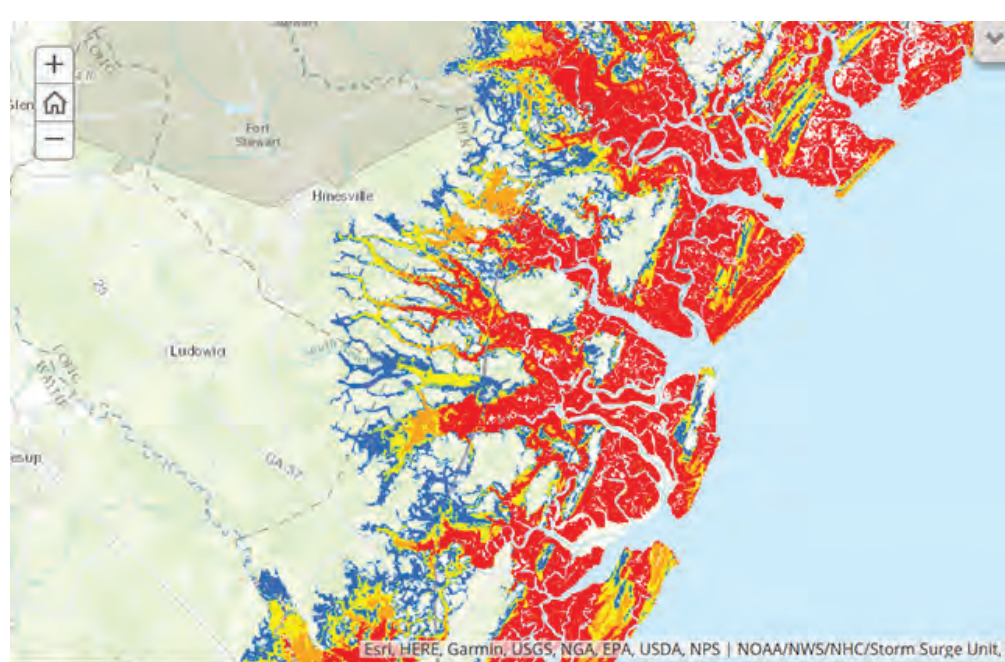
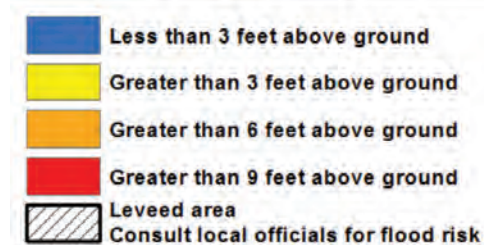
They show that even a Category 3 storm could push as much as three feet of water into low-lying areas of Hinesville. A Category 5 storm would swamp all of the city with that much water.

"These maps make it clear that storm surge is not just a beachfront problem, with the risk of storm surge extending many miles inland from the immediate coastline in some areas," the NHC's website that presents the maps says.

The site encourages anyone who lives within a threatened area to evacuate when orders are issued.

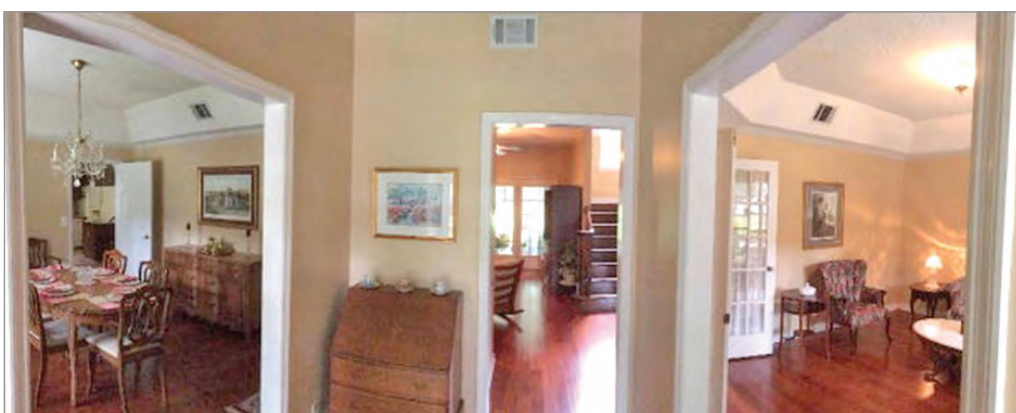

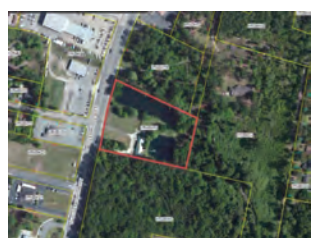

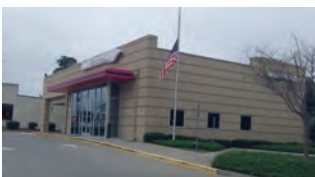
